**RENTER HEREBY AGREES TO THE FOLLOWING IN REGARD TO THE ABOVE MENTIONED RENTAL:**

1. Lessee is aware that there are risks inherent in the operation of a bicycle inline skates, skates or boogie boards, including the possibility of serious physical injury and voluntarily and knowingly assumes those risks in renting this equipment. Lessee also assumes liability for any and all property damages or personal injuries, including his or her own, arising out of operation of the bicycle, inline skates, skates or boogie boards rented pursuant to this agreement.
2. PLEASE THINK SAFETY FIRST. Check the mechanical operation of your bicycle, inline skates - including especially bicycle brakes. We will be happy to repair, adjust or replace your rental equipment.
3. Operators of bicycles, inline skates and skates must obey all laws. FOR YOUR SAFETY AND THE SAFETY OF OTHERS. ALWAYS USE HAND TURN SIGNALS. RIDE WITH DIRECTION OF TRAFFIC TO THE FAR RIGHT AND BE ON THE LOOK OUT FOR CARS, BICYCLES, SKATERS AND PEDESTRIANS. NO RACING OR RECKLESS USE OF YOUR EQUIPMENT IS PERMITTED. Such misuse automatically results in the immediate termination of your rights under this Rental Agreement and further operation for the rental equipment is prohibited.
4. SAFETY EQUIPMENT IS AVAILABLE, HELMETS, KNEE AND ELBOW PADS, WRIST GUARDS - USE THEM.
5. Lessee agrees to identify and hold harmless Rental On The Beach, Rollerblade, Inc. and the County of Los Angeles together with their employees, officers, directors and agents against all liability for claims, lawsuits, damages, losses and costs, including lawyer's fee.
6. Bicycles shall be operated on the beach bike path and on streets with bike lanes to and from this rental location.
7. Inline skates and skates shall be operated only where lawful and safe. Do not use the bike path; inline skates and skates are prohibited. You may be ticketed by police.
8. Lessee will be responsible for any loss or damage to the rental equipment. If equipment rented pursuant to this agreement is not returned, regardless of reason for Lessee failure to do so including theft by a third party. Lessee is responsible for reimbursing lessor for the retail replacement cost of identical new equipment or if such identical equipment is not available for equipment which is of at least equivalent value.
9. Lessor is not responsible for non-deposit items left on premises.
10. Minimum charge is (1) hour. I agree to pay double the posted rate if I return after the posted closing time. NO EXCEPTIONS.
11. Not returning items rented constitutes theft.
12. I have read and understand the terms for this agreement.
